# WHAT IS ADA COMPLIANCE?

People with disabilities struggle with physical barriers to access on a daily basis, and the Americans with Disabilities Act or ADA protects the rights of these individuals to have safe access to public spaces. The consequences of an ADA violation to businesses who do not provide accommodations as the law requires can be severe.

Understanding these consequences will help you avoid ADA penalties for noncompliance and protect your business reputation while providing the safe and easy access your customers and visitors deserve.

ADA is a very broad and wide-ranging piece of legislation that covers a lot of different aspects of accessibility for people with disabilities. The part of the ADA that affects the way that businesses serve customers is called “Title III,” so you’ll hear accessibility legislation referred to “ADA Title III”

ADA Title III covers public areas. Businesses of all types have to make it possible for customers with disabilities to access their services. The law requires them to make “reasonable modifications” to their premises when necessary so that they can serve people with disabilities.

**This title is regulated and enforced by the U.S. Department of Justice. Businesses that are found to be non-compliant with Title III can face serious legal consequences**

# THE CONSEQUENCES OF NOT COMPLYING WITH ADA RULES



## ADA Fines for Noncompliance

Federal law allows fines of up to \$75,000 for the first violation and \$150,000 for additional ADA violations. States and local governments may allow additional fines and require businesses to meet a higher standard of accessibility than the ADA requires.

## Lawsuits Involving People with Disabilities

Government agencies, municipalities, health care facilities, and small businesses that do not provide adequate “public accommodation” leave themselves open to lawsuits, personal injury claims, and legal or civil penalties should a disabled visitor be injured in a noncompliant space.

## Damage to Your Business Reputation

Perhaps the most financially damaging consequence of not complying with the Americans with Disabilities Act is the damage to the image of your business or brand when it becomes public record that there was a serious violation under ADA laws.

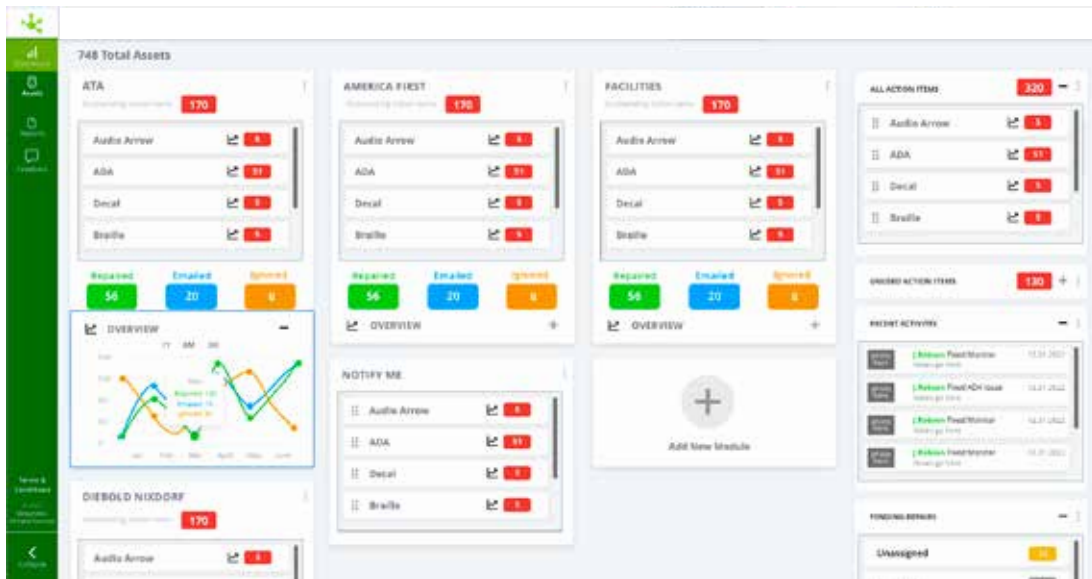

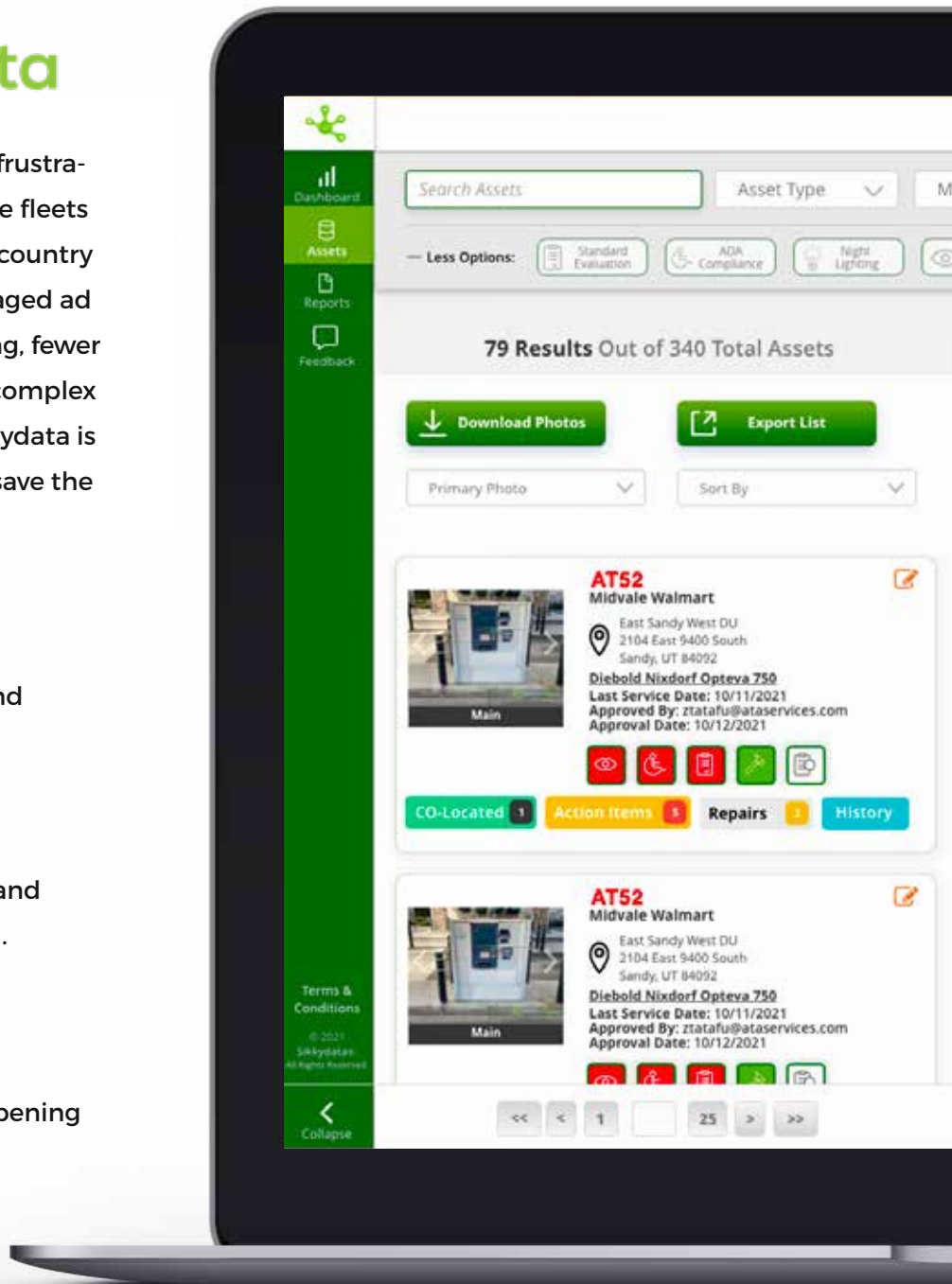
